The designation of a Title IX Coordinator is a federal mandate. There is frequent turnover and transition of these roles. This document contains the available names and contact information for Title IX Coordinators from each school in the Campus Accountability Map + Tool (CAMT). Next to each contact is the date on which it was confirmed. This information is not included in the CAMT because it changes so often. In some cases, even when the Title IX Coordinator has changed, their contact information remains the same. This is often the case when the contact email includes "TitleIXCoordinator", "Title9", "TitleX", "Equity", or other similar aliases.

End Rape On Campus recommends visiting the website listed in the CAMT to look for current Title IX Coordinator contact information directly.
